On December 15, 2009, at approximately 1600 hours, I observed a red van with an Air-Force sticker on the rear window traveling west on Highway 98, Destin, FL. A bolo had just been provided in reference to a red minivan with an Air-Force sticker on the window, fleeing a residential burglary in Destin.

As I made a u-turn in the area of Fisherman Wharf, the vehicle immediately turned north onto Palmetto Street. I attempted to catch up to the vehicle, but the van quickly sped through the stop sign at Mountain Drive and made a right turn into the Nightgown parking lot. I soon observed the van at Palmetto Street, traveling west in the westbound lanes fleeing D/S D. Culberson. As I pulled out of Palmetto Street in my marked Okaloosa County Sheriff's Office SUV, with the emergency lights and siren activated, the van traveled across the median and over the shoulder into the former Capt Kidd's Restaurant parking lot. The van continued at a high rate of speed down to the Lucky Snapper / Legendary Marina parking lot and over to the Entrance of the Emerald Grande. I attempted to follow as it traveled back onto Hwy 98 and began heading west over the Marler Bridge onto Okaloosa Island.

As I reached Hwy 98, I observed the van traveling on the shoulder, over the hump, of the Marler Bridge. Other traffic on the bridge was slowing and stopping, allowing the van passage. I continued through the traffic, and observed the van weaving from the roadway to the gravel shoulder passing slower moving traffic. I estimate that the van was traveling at a speed of 70 MPH, as I was traveling at 70 MPH attempting to follow.

As I rounded the curve at the U.S. Coast Guard Station, I observed the van pass another vehicle on the gravel shoulder of Hwy 98. At this point, I was approximately 100 yards behind the van. As the van traveled onto the shoulder, the operator over corrected losing control and crossed both westbound lanes. The van continued across the median, sliding sideways and crossed into the path of the eastbound traffic. The van's rear right quarter panel struck a white Chevrolet SUV (TX-5497AR) head on.

I secured the suspect vehicle, noting the operator injured and partially laying out of the front passenger window not moving. Florida identification was located on this suspect identifying him as Lloyd Poole. EMS responded and transported Poole to the Fort Walton Beach Medical Center for evaluation. The operator of the white van, Patricia Ambrose was also transported to the Medical Center with a fractured L5 and L12 vertebrae.

This offense occurred in Okaloosa County, Florida, where the affiant is a sworn Law Enforcement Officer. I have just and reasonable cause to believe, and do believe, that the above named defendant, Lloyd Poole, demonstrated a wanton disregard for the safety of persons, while causing serious bodily injury to another in an attempt to flee and elude law enforcement. This offense is classified as Aggravated Fleeing and Eluding Law Enforcement, pursuant to F.S.S. 316.1935(3b).
