The undersigned certifies and swears that he/she has just and reasonable grounds to believe that the above named defendants committed the following violation of law ON OR BETWEEN 07/01/2007 AND 07/01/2008, AT 1430 WASHINGTON DRIVE, PANAMA CITY, BAY COUNTY, FLORIDA, SOPHIA LYNETTE BRIGHT DID KNOWINGLY AND INTENTIONALLY SHOW HER MALE CHILD, CURRENTLY AGE 8, AND HER FEMALE CHILD, CURRENTLY AGE 6, A PORNOGRAPHIC MOVIE DEPICTING MEN AND WOMEN OR JUST WOMEN, ENGAGED IN SEXUAL ACTIVITY. THE CHILDREN WERE ABLE TO RECOUNT THE SEXUAL DIALOGUE, SEXUAL ACTIONS AND THAT THE ACTORS WERE NOT WEARING CLOTHES IN THE MOVIES. THE CHILDREN STATED THEIR MOTHER FORCED THEM TO WATCH THE MOVIES BY PLAYING THE MOVIES NUMEROUS TIMES AND TELLING THEM TO TURN AROUND AND WATCH WHEN THE CHILDREN TRIED TO COVER OR AVERT THEIR EYES. THE CHILDREN STATED SOPHIA BRIGHT MADE THEM WATCH THE MOVIES ON FIVE OR SIX DIFFERENT OCCASIONS WHEN THEY LIVED WITH HER. THE CHILDREN HAVE SINCE STARTED ACTING OUT SEXUALLY ON OTHER CHILDREN AND SHOWING INAPPROPRIATE BEHAVIOR SINCE AND STATE THEY LEARNED THE BEHAVIOR FROM THE MOVIES THEIR MOTHER SHOWED THEM.
