Narrative

ON OCTOBER 28, 2009 I WAS DISPATCHED TO THE CORNER OF FRONT BEACH ROAD AND 16TH STREET IN REFERENCE TO A VEHICLE ACCIDENT WITH INJURY. I ARRIVED AT THE ABOVE LOCATION APPROXIMATELY TWO (2) MINUTES AFTER BEING DISPATCHED. AS I ARRIVED, I WAS MET BY THE COMPLAINANT, RICHARD SERVIK WHO STATED, "MY GIRL FRIENDS TWO (2) KIDS HAVE BEEN HIT BY A CAR AND ONE

OF THEM IS DEAD."

AT THIS TIME, I NOTICED SEVERAL ADULTS GATHERED AROUND A WHITE MALE JUVENILE WHO WAS ALERT AND CONSCIENCE, BUT IN SEVERE PAIN AS HE WAS SCREAMING, "MAMA, MAMA." I MADE CONTACT WITH THE FEMALE THAT WAS LYING BY THE JUVENILE AND SHE INFORMED ME THAT "THIS IS MY SON AND MY DAUGHTER IS IN THE MIDDLE OF THE ROAD." I RELOCATED TO THE MIDDLE OF FRONT BEACH ROAD AND NOTICED A WHITE FEMALE JUVENILE LYING ON HER BACK WITH A SEVERE HEAD WOUND. I PLACED A BLANKET OVER THE FEMALE JUVENILE AND EMS ARRIVED A FEW MINUTES LATER AND PRONOUNCED THE FEMALE JUVENILE DEAD AT APPROXIMATELY 0716 AM. EMS TRANSPORTED THE MALE JUVENILE TO BAY MEDICAL CENTER, ALONG WITH THE MOTHER OF THE JUVENILES. (BOTH JUVENILES INVOLVED HAVE THE SAME MOTHER) ALSO, PRIOR TO LEAVING THE SCENE, I WAS ABLE TO OBTAIN ALL OF THE INFORMATION CONCERNING THE JUVENILES AND THE JUVENILES MOTHER.

BY THIS TIME, FHP HAD ARRIVED AND I BRIEFED TROOPER MCNABB, BADGE #2390 WITH THE INFORMATION THAT I HAD OBTAINED.

I WAS ABLE TO LOCATE TWO (2) WITNESSES CONCERNING THE ABOVE INCIDENT. THE FIRST WITNESS I SPOKE WITH WAS JON HATCHER, FROM VERNON, FLORIDA. JON STATED THAT HE WAS "TAKING AN ICE CHEST OUT TO HIS VEHICLE WHEN HE SAW TWO (2) KIDS PLAYING IN THE ROAD AND THAT A VEHICLE SWERVED AND TRIED TO MISS THEM BUT IT HIT THEM AND THREW THE LITTLE GIRL A FEW FEET."

I LOCATED AND SPOKE WITH THE SECOND WITNESS, STEVEN BOYD. STEVEN STATED THAT HE SAW "THE VEHICLE DRIVING WEST BOUND ON FRONT BEACH ROAD AND THE TWO (2) KIDS WERE PLAYING IN THE ROAD AND THE DRIVER TRIED TO SWERVE AND MISS THEM BUT COULDN'T SWERVE IN TIME AND HIT THE TWO (2) KIDS."

BOTH WITNESSES WERE ABLE TO IDENTIFY THE DRIVER OF THE VEHICLE THAT HIT THE TWO (2) JUVENILES.

I HAD OBTAINED THE DRIVERS LICENSE, REGISTRATION, AND INSURANCE INFORMATION OF THE DRIVER OF THE VEHICLE AND PROVIDED THIS INFORMATION TO TROOPER MCNABB. PRIOR TO LEAVING THE SCENE, I MADE CONTACT WITH THE DRIVER OF THE VEHICLE, KATHLEEN BELL JACKSON OF VERNON, FLORIDA. I MADE CONTACT WITH HER JUST TO VERIFY THE INFORMATION ON HER DRIVERS LICENSE WAS CORRECT AND TO OBTAIN A VALID TELEPHONE NUMBER. MS. BELL PROVIDED THIS INFORMATION WITHOUT ANY ISSUE.

I PROVIDED ALL OF MY INFORMATION TO THE FLORIDA HIGHWAY PATROL AND TURNED THE INVESTIGATION OVER TO THE TROOPERS THAT WERE ON SCENE. NOTHING FURTHER.
