**Narrative**

On Wednesday, October 28, 2009 I was contacted by Medical Examiner Investigator Michael Bates in regards to a death at the Emerald Shores Nursing Home located in Callaway, Florida. Bates stated that Belinda Briggs had died during the morning hours of October 26, 2009, while in the care of Emerald Shores. The body was initially turned over to a local funeral home. Bates said that he had spoken to Briggs' doctor, who had told him that Briggs was and had been in a coma since having been beaten and raped over 7 years ago in the State of New York. Due to the possibility that Briggs death was the result of that crime, Bates requested that I attend the autopsy on October 29, 2009 in event the death was ruled a homicide. I had CSI Mitchell respond with me to the autopsy, which he photographed. Doctor Hunter performed the autopsy and stated that it appeared that Briggs had aspirated food contents into her lungs as a result of her condition, and that it did appear that the death would be a homicide as a result of previous injuries obtained in the original battery in New York. This case is pending.
