Upon arrival I spoke with the victim [REDACTED] years of age, in the presence of [REDACTED] stated to me that [REDACTED] former [REDACTED] had molested [REDACTED] explained that approximately June of 2007 [REDACTED] met the suspect, later identified as James A Culotta, by a mutual friend. After speaking with Culotta, [REDACTED] offered [REDACTED] a job and [REDACTED] accepted. stated that in December of 2007 and began to work on training his horses among other jobs shortly after told me that she let Culotta because trusted her and thought Culotta, having a family of his own, would take care of as a

stated that approximately February of 2008 just finished taking a shower and when entered into room naked, Culotta was there sitting on bed. said that Culotta made a disturbing statement to about nudeness and immediately covered with a towel and Culotta expressed some disappointment about covering up. Shortly after this incident, approximately late March to early April, stated that Culotta's family had left the and went to Louisiana to visit family. stated that same night, approximately 1900hrs, Culotta gave bud light beer to drink in the barn located on the property. said that consumed two of these beers and Culotta then gave marijuana to smoke. said that smoked the marijuana out of a custom brown in color deer antler pipe that Culotta had supplied to . stated that and Culotta had consumed alcohol and marijuana and that consumed one more beer after smoking the marijuana for a total of 3 bud light beers.

At this time stated that went into the woods on the property to urinate. While urinating Culotta and began to urinate himself. Culotta then exposing his genitalia and asked liked his penis. said "It's nice I guess." and retreated quickly back to the barn. Once inside the barn Culotta entered with his genitals still exposed and approached . Culotta asked to touch his penis and stated to Culotta that wanted to go inside the residence in an attempt to get away from Culotta. stated that Culotta cornered in a room inside the barn and approached even closer. Culotta continually asked to touch his penis and continually pleaded that just wanted to go inside the residence. Culotta then grabbed against wishes, by the hand and placed it onto his penis. Culotta then grabbed other hand in an attempt to unzip pants. stated that and Culotta performed masturbation on each other that evening. I asked why did not fight off Culotta and said that was intoxicated, lived there, and that was afraid of Culotta.

I then asked if this was the only interaction that had with Culotta and stated no. stated that within this time frame, April through May 3, 2008, Culotta has initiated sexual contact with 10 to 12 times to include oral sex and masturbation. stated that performed oral sex on Culotta and Culotta performed oral sex on . I asked when was the last time had any sexual contact with Culotta and stated on last Saturday, May 03, 2008. stated that Culotta was able to talk over to his residence for what Culotta called ' '. When arrived Culotta's family was gone and and Culotta had oral sex. stated that on this day Culotta coerced into having anal sex as well. said that Culotta attempted to penetrate anally but stopped because screamed. said that stayed the night with Culotta and slept in Culotta's bed with and left at approximately 0630hrs the next morning. stated to me that was very afraid of Culotta and that was afraid to tell anyone or the police until broke down and told . I then explained to that did the right thing and explained to that was a victim. I explained to

rights, options, and how to obtain an injunction for protection. also stated to me that Culotta was continually calling family since last Saturday trying to reach I then contacted Sgt. James and explained to the situation and notified Det. Lio of Major Crimes. I supplied with my information, case number, and a witness statement that I will retrieve upon completion due to the immense details of statement. I explained to that would be contacted promptly by myself and an investigator from the Major Crimes Unit. stated that was going to stay with in Pensacola, Fl. for safety and supplied me with cell phone number along with a good cell phone number for A DCF fax transmittal form will also be completed and transmitted this evening. I told to not speak with Culotta in reference to this matter. was able to positively identify the suspect, James A. Culotta, by a picture I showed from Culotta's Florida Driver's License. I also completed a false information affidavit that will be retained in records.

Per Sgt. Lio this report will be forwarded to the Major Crimes Unit for further investigation. This offense occurred in Santa Rosa County, Fl.

On 05/11/08 I contacted the victim stated that was not finished with witness statement at this time due to its length. said that should have it complete tomorrow on 05/12/08. I will contact then in regards to this matter.
