[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 10/30/2008 members of the Pensacola Police Department Vice & Narcotics Unit entered Scenic Bluffs Park located on Scenic Highway, within the city limits of Pensacola, in reference to complaints of lewd behavior occurring within the park. I entered the park in an undercover capacity in an effort to enforce Florida State Statutes and the ordinances of the City of Pensacola if any violations occurred. As I walked on a dirt trail within the wooded area of the park, I came into contact with a white male who identified himself to me as "Steve". The suspect was wearing brown khaki pants, a brown t-shirt, with a long sleeve white shirt underneath, and tennis shoes. The suspect and I engaged in a short conversation as to the surroundings. During this time, I was seated on a broken tree, and the suspect was standing approximately 6-8 feet away from me. I observed the suspect fondling his genital area with his hand through the outside of his pants. The suspect then walked to an area behind me, and was approximately, 10-12 feet away from me. I observed the suspect unzip his pants and expose his erect penis. I observed the suspect clearly masturbating with his penis exposed within Scenic Bluffs Park. I began to approach the suspect, and he placed his penis back inside his pants. I made contact with the suspect and identified myself as a Pensacola Police Detective and informed the suspect that he was under arrest. The suspect's zipper was still unzipped. There were no areas of wetness on the ground or any other evidence to indicate that the suspect was doing anything other, such as urinating, than what I observed. I escorted the suspect to the parking lot along with Detective M. Lawrence #170. The suspect then identified himself as Randall Charles Nelson. Nelson identified his vehicle as a Saturn rental car bearing Florida tag V785ZY parked in the lot. Nelson indicated that his phone and wallet were located within that vehicle. I recovered those items from the vehicle at Nelson's request. I advised Nelson of his Miranda Rights in the presence of Detective Lawrence. Nelson stated that he was driving by, thought the park looked nice and was going for a walk. Nelson denied that he was exposing himself or masturbating. Nelson denied that he fondled his genitals through his pants.

Nelson was transported to the Pensacola Police Department and then to the Escambia County Jail.

It should be noted that this incident occurred during daylight hours in Scenic Bluffs Park which was open to the public and is frequented by individuals and families and children for legitimate purposes.
