[STATEMENT OF PROBABLE CAUSE / NARRATIVE]

Sometime during the months of February and March, 2009, JAMES LAIRD SEEGARS JR, a coach for Rocky Bayou Christian School, began a, improper, verbal relationship with, 14 year old _____ a student at Rocky Bayou Christian School.

On June 10, 2009, the verbal relationship between JAMES LAIRD SEEGARS JR. and _____ turned physical, when JAMES LAIRD SEEGARS JR. brought _____ to his office, at Rocky Bayou Christian School and kissed her on the lips. On June 11th 2009, JAMES LAIRD SEEGARS JR. again had _____ in his office, where he hugged and kissed her. Only this time he kissed her with his tongue. JAMES LAIRD SEEGARS JR. continued this lewd relationship with _____ for a few weeks. During one of their many sessions in JAMES LAIRD SEEGARS JR.'s office, while they kissed, JAMES LAIRD SEEGARS, grabbed _____ buttock, over her clothing and stated " I love to grab your butt while we kiss".

During a video taped interview, JAMES LAIRD SEEGARS JR. was read his Miranda Rights. JAMES LAIRD SEEGARS JR. agreed to speak with and answer question pertaining to this case. During the interview JAMES LAIRD SEEGARS JR. did admit to having a verbal and physical relationship with _____

Based on this investigation, this officer has reason to believe and does believe JAMES LAIRD SEEGARS JR. did violate F.S.S. 800.04.5c2 Lewd and Lascivious Molestation on victim under 16 years old. This offense did occur in the City of Niceville, Okaloosa County, Florida.
