

Also, on October 13, 2009 the victim was taken to the Children's Advocacy Center in Niceville, FL. for a forensic interview and a medical examination. After the medical examination was complete, Dr. Lynn Keefe advised there was evidence of sexual activity discovered on/inside the victim.

On October 14, 2009, after being advised of his rights, Sean Murphy denied any sexual contact with the victim at all and advised the victim never came into the bathroom with him, nor did he force her to come into the bathroom with him. Sean Murphy then requested to talk with me a second time and then admitted to the sexual activity with the victim. He also advised the victim pulled his pants/underwear down and gave him oral sex and then engaged in sexual intercourse with him. Sean Murphy further advised he had to get rid of all the evidence because it would be the link the victim could use against him.

I have reason to believe and do believe that Sean Murphy violated Florida Statute 794.011(5), Sexual Battery in Okaloosa County, Florida.


