[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

On 11/30/2009, at approximately 0208 hrs, Jarvis Jerel Hill, the defendant, committed Armed Burglary, Possession of Burglary Tools, Concealed Weapon, and Possession of Drug Paraphernalia. This incident was witnessed by

me in the curtilage of the Santa Rosa Mall located at 300 Mary Esther Blvd, Mary Esther, FL.

On 11/28/09, a burglary was done at the Santa Rosa Mall so I conducted an exterior security check of the Santa Rosa Mall on the north side entrance near the Food Court. During my check I noticed a piece of plywood removed that covered a broken window. The broken window was a result from the burglary two nights before. On the ledge below the window was a fisherman style glove. I self dispatched an open window call to OCSO Dispatch and asked for backup units. At this time I heard a noise near a dumpster that is hidden by a six foot high concrete wall by the same entrance. I walked behind the wall and shined my flashlight directly on Hill where he was hunched over a bicycle. I immediately told Hill to get on the ground in which he did. I approached Hill while he was on the ground and placed him in handcuffs. I read Miranda Rights to Hill and asked him if he had weapons hidden on his person and he said no. While searching Hill, D/S Landis discovered a dirk in his back pants pocket. Hill also had two screwdrivers in his left front pants pocket and a small cellophane bag that appeared to have cocaine residue in his right front pants pocket. Near the bicycle a paint scraper was found and another glove matching the one under the broken window.

During questioning Hill said he was just picking up his bicycle and would not say anything else. A field test with cobalt solution was used along with a sterile swab on the cellophane bag. The result indicated the color blue indicating presence of cocaine.

Based on my investigation I have reason to believe Jarvis Jerel Hill committed armed burglary, possession of burglary tools, concealed weapon, and possession of drug paraphernalia, in violation of F.S.S. 810.02(2)(b), 810.06, 790.01(1) and 893.147(1). These offenses occurred in Okaloosa County, Florida.
