ADDENDUM OF PROBABLE CAUSE

On this date, Communications received a call from Intimate Treasures advising a shoplifting incident had just occurred. The complainant advised the suspect vehicle displayed FL tag 8960HA and was described as a white older model Ford Explorer. The driver was described as a black male and the female suspect was described as a white female with dark hair, approximately 200 lbs, dark color "spaghetti string" top and blue jeans, and carrying a pink handbag. The suspect vehicle was last seen southbound on Mary Esther Cutoff.

Officers in the area located the vehicle at the intersection of Hollywood Blvd and Beal Pkwy. The FL tag 8960HA did not return to the vehicle to which it was attached. After conducting a traffic stop, the white female suspect described was in the front passenger seat with a pink handbag at her feet. The female initially identified herself as Melody Higgs and stated she possessed a Florida ID card. A search of DHSMV revealed negative results.

The female suspect, later identified as Melody Sanders, was also removed from the vehicle and detained. A search of Defendant Sanders' person was conducted. A foil gum wrapper was located in her front right pants pocket. Inside the foil, officers located three rocks of suspected crack cocaine. Also inside the pocket, officers located a glass tube with burnt "Brillo" stuffed in one end. I immediately recognized the object as a common device used to smoke crack cocaine. A search of the pink handbag in the front passenger floorboard revealed four items, which were later identified as stolen from Intimate Treasures. In a separate handbag in the front passenger floorboard, officers located a FL driver's license with Defendant Sander's photograph and information. A records check through DataShare revealed the Santa Rosa County Sheriff's Office possessed a warrant for Defendant Sanders for FTA on the original charge of battery.

A show up was conducted with the complainant and Defendant Sanders was immediately and positively identified as the female suspect who had been in the store. The complainant also verified the suspect stolen items were from her store. The items were labeled with the same computer generated price tags used by the store. They were also the same items Defendant Sanders were witnessed carrying in her arms as she walked through the store. Prior to leaving the store, Defendant Sanders was approached by the complainant and asked what she had done with the property. Defendant Sanders replied she had replaced the items and the departed the store passing the point of sale. The complainant quickly verified the items were still missing from their display locations and obtained the suspect vehicle license plate prior to their departure. Defendant Sanders was clearly visible in the store video obscuring herself from employee view by kneeling behind a display rack while concealing the items in the pink handbag. The stolen items were a Triple Indulgence Personal Massager, a Spartacus Leather Thong Whip, Climax Tingling Lube, and Sex Tarts Lemonade Lube and totaled \$172.80.

To wit, Defendant Melody Sanders was knowingly in possession of a control substance; was knowingly in possession of narcotic paraphernalia; did knowingly and willingly take possession of merchandise with the intent to deprive the merchant of said merchandise; and did knowingly and willingly provide a false name while lawfully detained.
