



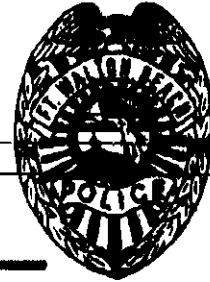

The undersigned certifies and swears that he/she has just and reasonable grounds to believe, and does believe that the information below and that contained on the above citation(s) is true and correct:

On 6-23-2010 at about 2035, John Campbell Arthur operated a 2006 Chevrolet sedan traveling north on Country Club Ave. Mr. Arthur operated the vehicle while his driving privilege was cancelled. Mr. Arthur operated the vehicle in a careless manner and caused a crash resulting in the death of 16-year-old [REDACTED]

Michael Ingram was driving his vehicle north on Country Club Ave approaching Eagle St when he saw Mr. Arthur's vehicle approaching from behind at a rate of speed so high Mr. Ingram found it necessary to leave the roadway and pull over onto the shoulder. Mr. Ingram observed Mr. Arthur's vehicle run the posted stop sign at Eagle St and continue north on Country Club Ave. Mr. Ingram estimated Mr. Arthur's speed at over 50MPH in the posted 25MPH zone. Mr. Arthur's vehicle then struck the left side of [REDACTED] vehicle as [REDACTED] was turning into the driveway of 631 Country Club.

I examined the crash scene and determined the impact occurred about 105 feet north of a marked no-passing zone. I examined the extensive damage to all vehicles involved and determined there was evidence of excessive speed. I observed gouges in the pavement, broken glass, and other debris in the southbound lane indicating Mr. Arthur's vehicle was completely in the southbound lane (left of the centerline) when the impact occurred.

A review of Mr. Arthur's driver's license record indicated his driving privilege was currently cancelled and there were numerous suspensions, DUIs, and other traffic offenses in recent years on record.

Mr. Arthur denied driving the vehicle. However, Michael Hull and Karen Baker observed Mr. Arthur in the driver seat of the vehicle.

This offense occurred in the City of Fort Walton Beach, Florida in violation of FSS 322.34(6)(b).





While performing traffic enforcement near 202 NE Eglin Parkway I observed a white in color Cheverolet Impala bearing Florida registration N223GF traveling northbound on Eglin Parkway at a high rate of speed. Using a radar speed measuring device, I clocked the vehicle at 90 m.p.h. in a posted 30 m.p.h. speed zone. I immediately traveled northbound on Eglin Parkway in attempt to perform a traffic stop on the vehicle. The vehicle began to accelerate and I was unable to get close to the vehicle to initiate a traffic stop. The driver of the vehicle, later identified as JOHN CAMPBELL ARTHUR then began flashing his high-beam headlights at other drivers to quickly pass the heavy traffic on Eglin Parkway. While traveling northbound on Eglin Parkway ARTHUR made a sudden left, westbound turn onto Racetrack Road from Eglin Parkway, driving through the red traffic signal at the intersection. ARTHUR then continued traveling westbound on Racetrack Road continuing to flash his vehicle's high-beam headlights traveling through a red light at Mooney Road, passing stopped vehicles by traveling over the median. ARTHUR continued westbound on Racetrack Road at a high rate of speed, making sudden unsafe lane changes to avoid other vehicles. ARTHUR continued traveling westbound on Racetrack Road at a high rate of speed continuing to flash the vehicle's high-beam headlights and activated the vehicle's hazard lights prior to traveling through the red light of Denton Blvd. and Racetrack Road. ARTHUR began to open the driver's door and I immediately grabbed his arms and pulled him from the vehicle to place him under arrest for Reckless Driving. 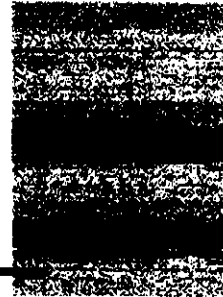

ARTHUR then continued traveling westbound on Racetrack Road continuing to flash his vehicle's high-beam headlights traveling through a red light at Mooney Road, passing stopped vehicles by traveling over the median. ARTHUR continued westbound on Racetrack Road at a high rate of speed, making sudden unsafe lane changes to avoid other vehicles. ARTHUR continued traveling westbound on Racetrack Road at a high rate of speed continuing to flash the vehicle's high-beam headlights and activated the vehicle's hazard lights prior to traveling through the red light of Denton Blvd. and Racetrack Road. I continued to follow the vehicle still unable to safely get behind the vehicle to initiate a traffic stop. P.O. Reynolds also attempted to get behind the vehicle on Racetrack Road near Beal Parkway but due to heavy traffic and ARTHUR driving at a high rate of speed he was unable to catch up to ARTHUR. ARTHUR then made a sudden right, northbound turn onto Beal Parkway from Racetrack Road from the inside left lane of Racetrack road, failing to stop for the red light. ARTHUR then accelerated rapidly northbound on Beal Parkway in the inside lane making a sudden right turn into the Taco Bell parking lot, 945 NW Beal Parkway.

I immediately pulled into the parking lot behind ARTHUR and he accelerated through the parking lot making a sudden turn into the drive-thru lane where he suddenly stopped the vehicle (There were other vehicles in the drive-thru lane, blocking ARTHUR'S forward path). I immediately exited my patrol car and ordered ARTHUR to turn off the vehicle. ARTHUR began to pull away and I had to order ARTHUR again to stop the vehicle and turn the ignition off. ARTHUR began to open the driver's door and I immediately grabbed his arms and pulled him from the vehicle to place him under arrest for Reckless Driving. ARTHUR was asked if he had any weapons on him and he stated, "I have a concealed gun by my seat". ARTHUR was placed under arrest and P.O. Reynolds located a stainless steel colored Smith & Wesson .40 caliber semi-auto handgun, serial number TFE9165 wedged between the vehicle driver's seat and center console with a live round in the chamber, hammer back, safety off with more live rounds in the magazine. The handgun was readily accessible by ARTHUR and was fully concealed from view by ARTHUR's body while he was sitting in the drivers seat. A DHSMV check revealed that ARTHUR has had three prior DUI charges, with his license being Revoked for ten years on 07-18-2008.

ARTHUR was placed under arrest for Carrying Concealed Weapon, Reckless Driving and Knowingly Driving While License Suspended/Revoked and Driving While Under The Influence of Alcohol/Drugs.

The above offenses occurred within the City Limits of Fort Walton Beach, Okaloosa County Florida and are in violation of F.S.S. 790.01(2), F.S.S. 316.192, F.S.S. 322.34(2) and 316.1939(1).

PROBABLE CAUSE:

On 05-10-2008 I was traveling south on 12th St in Shalimar in my marked patrol vehicle. I observed a 2002 gold Chevrolet Trailblazer travelling north, in my lane of the roadway, approaching head-on towards my vehicle. I was forced to swerve into a driveway to avoid a collision. I observed a white male driver with dark, short hair in the driver's seat and no one in the passenger seat, due to both front windows being in the down position. I immediately turned around activating my emergency equipment. At this time, the vehicle increased its speed in an attempt to avoid a traffic stop and I felt the vehicle was trying to flee. The vehicle pulled into the driveway at 59 Junior Dr. Upon approach of the vehicle, bearing Florida license plate E058SW, I observed both doors had remained closed and there was no one in the driver's seat. The defendant, identified as John C. Arthur, was located in the front passenger seat. At no time did I lose sight of the vehicle and never observed anyone exit the vehicle. The defendant immediately stated, "I wasn't driving, it was the guy that ran." A DHSMV check confirmed the defendant driver's license had been suspended 13 times, with notice given and did not currently have a valid driver's license. This violates F.S.S. 316.192 (1) (a) Reckless Driving and 322.34 (2) Knowingly Driving While License Suspended.


