[ STATEMENT OF PROBABLE CAUSE / NARRATIVE ]

ON AUGUST 11, 2009 TERESA F. MCKEE, WHO RESIDES AT 559 MCKEE ROAD, DID COMMIT THE OFFENSE OF HOMICIDE. MCKEE BRANDISHED A 12 GAUGE PUMP SHOTGUN. MCKEE FIRED TWO ROUNDS, ONE STRIKING THE VICTIM, STEPHANIE LOCKWOOD, IN THE LEFT SIDE OF HER FACE, CAUSING HER DEATH. SUBSEQUENT TO MIRANDA RIGHTS ADVISEMENT AND WAIVER, MCKEE CONFESSED TO THE ABOVE FACTS. THIS INCIDENT DID OCCUR IN WALTON COUNTY FL AND IS IN VIOLATION OF FSS 782.04.
